GOVERNMENT RELATIONS UPDATE

Well, the Sunset Review process continues and we continue to represent you. In these last few weeks, AB 178 and 179 have continued through the approval process. Here is where they stand:

As of right now, AB 179 has been passed by the Assembly (June 1) and ordered to the Senate, where it has been referred to committee/s and amended. It was passed by the Senate Business, Professions and Economic Development Committee and has been re-referred to Committee on Appropriations (July 6).

This bill addresses the issues raised during Sunset Review and would extend the authority of the Dental Board until 2020, would limit the term of a Dental Assisting Council member to two terms, places a temporary moratorium on the Practical Exam and requires the DBC to conduct a review to determine whether a practical exam is necessary and increases fees.

AB178 is the emergency legislation proposed by the legislature and imposes a one-year moratorium on the RDA practical until

such time as the Board and the State Office of Professional Examination Services (OPES) concludes a validating assessment called an Occupational Analysis. It does the same thing that AB 179 will do, but the intent was to get an immediate halt to the RDA Exam because of the fluctuating and high failure rate.

It was last heard by the Senate Business, Professions and Economic Development Committee on June 29, where it was passed (7/0) and re-referred to Appropriations Committee. It was scheduled to be heard on July 13, right before they went on summer break.

The next Dental Board meeting is scheduled for August 27-28 (location still TBD) and we anticipate that the next regulatory language workshop will be held in conjunction with the Board meeting. We will keep you posted as to the topics for that workshop and the date.

The 1st and 2nd Occupational Analysis Workshops will be held in the coming weeks and as we hear back, we'll report to you. The deadline for the 3rd and 4th Workshop of November 20th, so there's still time to submit your name to participate! Here's the link (http://www.dbc.ca.gov/formspubs/rda_sme20150520.pdf).

Claudia and I had been asked to develop five presentations for our trip. We would be teaching in two different cities to a group of dentists and assistants. The topics were:

A Day in the Life of an Assistant, Infection Control, Implants, Communication, and Oral Health/Hygiene. Each day of teaching would also include a clinical portion with hands-on demonstrations of chairside assisting.

So there we were, in a foreign land, depending solely on Linda to be our interpreter throughout the entire trip as none of our other hosts spoke English. So after 14 hours traveling, off we went on a 3 hour car ride to our first destination, to prepare for an 8:00 am class the next morning. And so we literally hit the ground running. We arrived in Hangzhou, had a wonderful dinner and then retired to our hotel to try to get some sleep. End of day one.



Day two, our class ran all day and into the evening. The venue was the local hospital which also had a dental clinic. The students were very receptive to the material and everyone was very warm and friendly.

Our hosts were amazing and though there was no real exchange of English, we were all able to communicate our appreciation for one another and share our mutual love of dentistry.





We both met Linda during our annual meetings of the American **Dental Assistants Association** (ADAA). I was serving on the Board of Trustees and Claudia was on the **Executive Council and also served** as President for the ADAA. Claudia lives in Southern California, and as it turned out, Linda and I were geographically close to one another, with both of us living in the East Bay Area. As this trip was in the planning stages, Linda and I were able to meet to discuss the fine details surrounding this amazing trip.
