- If registration form is incomplete, it will be returned for clarification. Please print clearly to help process your registration in a timely manner. Complete the Meeting Registration Form including attendee's signature and payment information.
- Registration must be received or post-marked by the deadline date (March 19) to be eligible for posted fees and must include valid payment at the time of registration.
 CADAT/CDAA will not process a registration without receiving a valid form of payment.
- Space is limited, so register early! Hotel accommodations are limited, too, so book early!
- Late registrations will be accepted as space allows with inclusion of late fee.
- No registrations accepted after April 10th.
- Review the <u>Conference Code of Conduct</u> along with these Terms and Conditions <u>before signing your registration</u> form acknowledging such conditions.
- Confirmation will be sent via email.
- Registration fees are non-refundable and non-transferrable once processed.
- CADAT/CDAA reserves the right to refuse processing of any event registration or membership application in accordance with their associated Bylaws.
- CADAT / CDAA representatives will be taking photographs of the events which may be used in publications.
- Conference attendees will be allowed to participate in all registered events provided selected fees have been paid, the member is eligible to attend the event(s) and the member is deemed in good standing. In the event a registration is cancelled, all courses and events reserved for the member will be cancelled and seats will be issued to other registrants. In the event either the member or the Association reinstates the registration, the new registration will be ticketed with only those courses and events that are still open at the time of reinstatement, which may not be the same courses from the previous registration.
- The processing of credit/debit card information provided on this application is the member's responsibility or that of the person authorizing the use of such data in the payment of these fees. The authorizing signatory is approving such charge and any dispute of a charge to the account shall be reported and resolved by contacting the Association prior to any dispute filing with the card company.
