## Government Relations Update Shelly Sorensen, CDPMA, CRFDA, CDA, RDA

As you know from the last journal, the Dental Board is going through a Sunset Review process and changes and notations have been made known by CDAA, CADAT, and FADE. CDAA has been diligently advocating for the profession of Dental Assisting.

There are two bills, AB178 and AB179, which have been brought forward by Assemblywoman Susan Bonilla. Both have passed the Assembly and will soon be presented to the Senate. AB178 imposes a one-year moratorium on the RDA practical until such time as the Board and the State Office of Professional Examination Services (OPES) concludes a validating assessment called an Occupational Analysis. It does not permanently remove the practical examination. We are monitoring the progress of these two bills.

As part of this process, your CDAA representatives traveled to Sacramento, meeting with CADAT representatives and worked on the regulatory language the Dental Board of California is considering adopting into the Sunset Review documentation for AB179. We had the opportunity to meet with the legislative representatives regarding the status of AB 178 and AB 179. We were able to discuss with her some continuing issues related to the Sunset Review and as a result have submitted some amendments to the language that will strengthen our profession. These relate to the composition, tenure and leadership of the Dental Assisting Council and their responsibilities.

We also attended a Dental Assisting Council workshop on June 19<sup>th</sup> to review and discuss the regulatory language. During the workshop, the groups of assistants/ educators present gave feedback and input to the Council on the Radiation Health and Safety portion. That input will be put together and then reviewed again before being sent forward. Workshops will continue until all the language is reviewed; we anticipate that the next workshop will be scheduled before the next Dental Board meeting in August. We will keep you posted on the progress!
